

**REQUIREMENT TO PROVIDE ADDITIONAL INFORMATION FOR THE TALENTIA POSTDOC
FELLOWSHIP CALL FOR TRANSNATIONAL MOBILITY OF RESEARCHERS**

In accordance with the Regulations of Order of February 26, 2014 of the Regional Ministry of Economy, Innovation, Science and Employment establishing the Rules and Foundations of the Talentia Postdoc Fellowship Program published in the Official Gazette number 41 of March 3, 2014, the Secretary General as instructive body demands the compliance check of Applications received. A compliance check examines whether all required information is included in the dossier.

According to the legal text of Article 13 of the above mentioned order, (for English version see Summary of Call Regulations on our Web) if any document is missing or further information is needed, applicants will be notified and will have ten working days to provide the requested information. If this is not done, these applications will be withdrawn from the Evaluation process.

After the closing date for submission of Applications on 05/05/2014, the Agency examined the documentation in order to check whether the candidates have met their obligations.

This requirement includes a list of Applications that need to provide additional information. Applicants will have ten working days, counting from the day following publication of the requirement, to provide the requested information, completing the relevant sections on pages 1 and 2 of the Application Form.

We kindly request the candidates to provide the additional information in any Official Register, send Certified mail or via Spanish Embassy or Consulate abroad and to forward a pdf via e-mail to talentiapostdoc.aac@juntadeandalucia.es

Grounds of correction and list of Applications that need to provide additional information:

- B) Details and authorization for notifications – Section 2 of AF, page 1
- C) Declaration to meet the requirements to obtain the status of beneficiary – Section 4, page 1 of AF
- D) Statement concerning other subventions or grants for the same purpose related to the application from other administrations or public/private entities, national or international. – Section 4 of AF (please indicate entity and amount)
- E) Declaration not being involved in any of the prohibitions in the Regulations – Section 4 page 2 of AF
- F) Declaration that the application information is true – Section 4, page 2 (please sign)
