RESOLUTION OF JULY 22, COMPLEMENTARY TO THE RESOLUTION OF JULY 15, 2014 OF THE TALENTIA POSTDOC FELLOWSHIPS IN ACCORDANCE WITH THE REGULATIONS OF ORDER OF FEBRUARY 26, 2014 OF THE REGIONAL MINISTRY OF ECONOMY, INNOVATION, SCIENCE AND EMPLOYMENT ESTABLISHING THE RULES AND FOUNDATIONS OF THE TALENTIA POSTDOC FELLOWSHIP PROGRAM FOR TRANSNATIONAL MOBILITY OF RESEARCHERS.

PRFAMBLE

- 1. By Order of February 26, 2014 the rules and foundations of the Talentia Postdoc Fellowship Program are established and the Call for Applications of the Talentia Postdoc Fellowship Program is issued.
- 2. Applications have been received within the deadline and presented in the manner required in the Order of February 26, 2014. Procedures have been developed in accordance with the provisions of Article 16 of the Order.
- 3. A compliance check of Applications has taken place between May 29 and June 9, 2014 by the instructing entity notifying the applicants on May 28 in accordance with the provisions of Article 13 of the Order of February 26, 2014.
- 4. The Committee has been appointed as provided in paragraph 13 of the Call Summary of the Order of February 26, 2014. The Selection Committee has reviewed and evaluated the applications taking into account the criteria contained in section 12 of the Call Summary.
- 5. The Selection Committee of the Talentia Postdoc Program met in Cordoba on June 18, 19 and 20th and has drafted its provisional outcome including nomination of the provisional beneficiaries and candidates on the reserve list for each mobility scheme and of the applicants that did not pass the evaluation process.
- 6. The result was published in the Provisional Outcome of July 11, 2014 and candidates were informed they will have a period of 10 days to present Annex II as established in Article 17 of the Order of February 26, 2014.
- 7. July 15, 2014 Resolution declaring applications not admitted was published in accordance with Articles 12 and 13 of the Order of February 26, 2014.
- 8. On July 16, 2014 the collaborating entity observed that the compliance check of the application of Al-Zuheri, Atiya, who is included in Resolution of July 15, was fulfilled within the deadline and according to the provisions of Compliance Check of May 28, 2014.

A result of the above facts the following applies

LEGAL FOUNDATION

- 1. According to the provisions of paragraph 13 of the Call Summary of the Order of February 26, 2014, the Talentia Postdoc Committee is the entitled body to evaluate the applications and to elaborate the Provisional Outcome.
- 2. Also in line with paragraph 13 of the Call Summary of the Order of February 26, 2014 the Managing Directorate of the Andalusian Knowledge Agency is the entitled body to determine the outcome as described in article 115 of the revised text of the General Finance Law of the Junta de Andalucía.





By the above, on the grounds of the proposal made by the General Secretariat of the Andalusian Knowledge Agency, according to the provisions of paragraph 13 of the Call Summary and related to Article 15 of the Order of February 26, 2014

I DECLARE

- 1. Admit admissible the application of Al-Zuheri, Atiya having fulfilled the Compliance Check.
- 2. Therefore excluding his name from Annex II: applications that have not fulfilled the compliance check of Resolution of July 15, 2014, by amending the Annex.
- 3. Include the application of Al-Zuheri, Atiya in Annex III: candidates that did not pass the evaluation process of the Provisional Outcome of July 11, 2014, by amending the Annex.
- 4. As established in Article 17 of the Order of February 26, 2014, applicants will have a period of 10 days to claim following the terms provided in Article 84 of Law 30/1992 of November 26.
- 5. In line with the provisions of Article 18 of the Order of February 26, 2014 the collaborating entity will analyze the arguments presented within the deadline, check the provided documentation and draft the Final Outcome, which may not exceed the maximum total funding amount foreseen in the Call
- 6. According to Article 21 of the Order of February 26, 2014 and section 16 of the Call Summary, this resolution will be published in the websites of the Regional Ministry of Economy, Innovation, Science and Employment and Agencia Andaluza del Conocimiento. Publishing substitutes personal notification at all effects.
