RESOLUTION OF JULY 15, 2014 OF THE TALENTIA POSTDOC FELLOWSHIPS IN ACCORDANCE WITH THE REGULATIONS OF ORDER OF FEBRUARY 26, 2014 OF THE REGIONAL MINISTRY OF ECONOMY, INNOVATION, SCIENCE AND EMPLOYMENT ESTABLISHING THE RULES AND FOUNDATIONS OF THE TALENTIA POSTDOC FELLOWSHIP PROGRAM FOR TRANSNATIONAL MOBILITY OF RESEARCHERS, DECLARING APPLICATIONS NOT ADMITTED.

#### **PREAMBLE**
